The Scheme is now subject to the approval of the Hon'ble National Company Law Tribunal, Ahmedabad Bench, ('Hon'ble NCLT') where the registered office of the Transferor Company 4 i.e. JSW Steel (Salav) Limited is situated.

The Scheme would become effective once the Certified Copy of the Order of the Hon'ble NCLTs are filed by DMMPL, DCPL, JSPCL, JSW Salav and JSW Steel with the jurisdictional Registrar of Companies.
