Sub: US district Court's judgement in 'MM Steel' case.

Dear Sir,

Please refer to our letter dated 1st December, 2015 whereby we had informed that JSW Steel USA Inc. (JSWUSA), a subsidiary of the Company, is studying and analysing the judgement pronounced and evaluating all options available to defend its position under the applicable laws.

On December 22, 2015, JSWUSA filed a Petition for Rehearing En Banc by the Fifth Circuit. On March 21 2016, the Fifth Circuit rejected the petition and issued the mandate, triggering JSWUSA's obligation to pay the judgment. On 16th June 2016, the district Court entered an Order releasing JSWUSA from any further liability to MM Steel under the judgment in return for a payment of \$54,852,478.24. This payment has been made and JSWUSA intends to seek review of the Fifth Circuit's decision by filing a petition for writ of certiorari in the United States Supreme Court, which, if successful, could result in the refund of part or all of the funds paid to satisfy the judgment.
