Sub: Intimation under Regulation 37 (6) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('LODR Regulations") – Scheme of Amalgamation of Amba River Coke Limited ('ARCL' or 'the Transferor Company 1') and Monnet Cement Limited ('MCL' or 'the Transferor Company 2') and JSW Retail and Distribution Limited ('JRDL' or 'the Transferor Company 3') [the Transferor Company 1, the Transferor Company 2 and the Transferor Company 3 are collectively referred to as 'the Transferor Company') with JSW Steel Limited ('JSL' or 'the Transferee Company') and their respective shareholders ('the Scheme').

Dear Sir / Madam,

We refer to our letter dated October 17, 2025 submitted under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('LODR Regulations'), intimpating that the Board of Directors of JSW Steel Limited ('JSL' or 'the Transferee Company') and Amba River Coke Limited ('ARCL' or 'the Transferor Company 1') and Monnet Cement Limited ('MCL' or 'the Transferor Company 2') and JSW Retail and Distribution Limited ('JRDL' or 'the Transferor Company 3') [the Transferor Company 1, the Transferor Company 2 and the Transferor Company 3 are collectively referred to as 'the Transferor Companies'] have approved a Scheme of Amalgamation of ARCL, MCL and JRDL with JSL and their respective shareholders ('the Scheme') pursuant to Section 230 to Section 232 of the Comspanies Act, 2013, subject to requisite approvals as may be required. The Transferor Companies are wholly-owned subsidiaries of the Transferee Company.

In terms of Regulations 37(6) of the LODR Regulations, 2015 read with SEBI Master Circular No. SEBI/HO/CFD/POD-2 P/CIR/2023/93 dated 20th June, 2023 ("SEBI Circular"), the requirement of obtaining 'No-Objection Letter' or 'Observation Letter' to the Scheme from the Stock Exchanges is not applicable to this draft Scheme as it solely provides for merger of wholly owned subsidiaries with its holding company.

Further, in accordance with the provisions of Regulation 37(6) of the LODR Regulations read with the SEBI Circular, we hereby enclose the below mentioned documents for the purpose of disclosure:
