In addition to the case as mentioned in the previous disclosure, the Additional Commissioner of GST Central Tax (Belgavi Unit, Karnataka) issued an other show cause notice (SCN) on 19.06.2024, alleging that the Company wrongfully availed and utilised Input Tax Credit distributed through the Company's ISD registration in Mumbai. In response, the Company filed writ petition in the Hon'ble High Court of Karnataka. The Hon'ble Court heard the matter on 31.01.2025 and granted ad-interim stay in the matter.
