Dear Sir,

We write with reference to the earlier communication made by the Company on April 15, 2022 about JSW Utkal Steel Ltd (**JUSL**), a wholly-owned subsidiary of JSW Steel Ltd receiving environmental clearance (EC) for setting up of a greenfield Integrated Steel Plant (**ISP**) of 13.2 million tonnes per annum (MTPA) crude steel from the Union Ministry of Environment & Forest and Climate Change (MoEF&CC) which was further re-validated by MoEF&CC in September 2023 with additional and modified EC conditions.

We now inform you that of the total Land required for the project that is 2950.31 Acres, of which 2677.80 Acres was Forest Land, the Divisional Forest Officer, Mangrove Forest Division (WL), Rajnagar & the Collector have on January 4, 2024 delivered documents pertaining to the handing over of possession for the total forest land admeasuring 2677.80 Acres to JSW Utkal Steel Limited. The non-forest land of 272.51 Acres has already been leased in favour of JSW Utkal Steel Limited by the State Govt. of Odisha (259.95 Acres on 4th August 2022 and 12.56 Acres on 30th November 2023).
